- Presently acting as co-chief defense counsel in class action pending Rhode Island's trial court involving fifty defendants regarding the use of intrauterine devices.
- Advised two hospital chains comprising a majority of hospital institutions in Rhode Island regarding implementation of the federal Patient Safety and Quality Improvement Act of 2005 and the Rhode Island Patent Safety Act.
- After four week jury trial, obtained a defense verdict for a gastroenterologist who was alleged to have failed to properly diagnose and treat an infection which ultimately led to the loss of the plaintiff's eye.
